TWO YEARS FULL WARRANTY

Gaucha Grills grills and grilling inserts and all of their component parts, except as detailed below^{*}, are warranted to be free from defective materials or workmanship in normal household use for a period of twenty-four (24) months from the date of purchase. Argentum Creations LLC (D.B.A. Gaucha Grills), warrantor, agrees to repair or replace, at its option, any part which fails or is found to be defective during the warranty period.

This warranty extends to the original purchaser of the product warranted hereunder and to each transferee owner of the product during the term of the warranty.

This warranty shall apply to products purchased and located in the United States. Products must be purchased in the country where service is requested. Warranty labor shall be performed by an authorized Argentum Creations LLC service agency or representative. Warranty shall not apply to damage resulting from abuse, accident, natural disaster, alteration, improper installation, improper operation, or repair or service of the product by anyone other than an authorized Argentum Creations LLC service agency or representative. This warranty does not apply to commercial usage. Warrantor is not responsible for consequential or incidental damage whether arising out of breach of warranty, breach of contract, or otherwise. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

Owner shall be responsible for proper installation, providing normal care and maintenance, providing proof of purchase upon request, and making the appliance reasonably accessible for service. If the product or one of its component parts contains a defect or malfunction during the warranty period, after a reasonable number of attempts by the warrantor to remedy the defects or malfunctions, the owner is entitled to either a refund or replacement of the product or its component part or parts. Warrantor's liability on any claim of any kind, with respect to the goods or services covered hereunder, shall in no case exceed the price of the goods or service or part thereof which gives rise to the claim.

This Warranty only applies to products supplied and furnished by Argentum Creations LLC (D.B.A. Gaucha Grills). Argentum Creations LLC is not responsible in any way for the repair, replacement, maintenance, or service of any grilling installations, bases, fireplaces, fire pits, counter tops, or any other equipment or structure that the supplied grill is installed into, resides in, or interacts with.

Any Products which Gaucha Grills sells or adds on to existing grills and inserts, that Gaucha Grills does not manufacture or have manufactured specifically for us, shall carry the full manufacturer's warranty. Gaucha Grills reserves the right to discontinue any product we feel does not meet our quality requirements. Every attempt will be made to offer another item which performs a similar function and with better quality.

WARRANTY SERVICE: Under the terms of this warranty, service must be performed by a factory authorized Argentum Creations LLC service agent or representative. Service will be provided during normal business hours. Any labor performed at overtime or premium rates shall not be covered by this warranty. To obtain warranty service, contact the dealer from whom the product was purchased, an authorized Argentum Creations LLC service agent, or Argentum Creations LLC. Provide model and date

of original purchase. For the name of your nearest authorized Argentum Creations LLC service agency, call the dealer from whom the product was purchased or Argentum Creations LLC.

IMPORTANT: Retain proof of original purchase to establish warranty period. (Packing Slip)

Any implied warranties of merchantability and fitness applicable to the above described Grills and Grilling Inserts are limited in duration to the period of coverage of the applicable express written limited warranties set forth above. Some jurisdictions do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which may vary from jurisdiction to jurisdiction.

*(For grills with a Fire Brick base) Individual Fire Bricks are warranted to be free from defective materials or workmanship for a period of ninety (90) days from the date of delivery. ANY DEFECTS MUST BE REPORTED TO ARGENTUM CREATIONS LLC WITHIN NINETY (90) DAYS FROM DATE OF DELIVERY. Slight color variation and small chips or fissures may be noticed in various bricks due to the inherent nature of the coloring, fabrication, storage and transport of the bricks. However, if a brick is found to be cracked or broken in the course of normal operation and maintenance within the first 90 days of delivery of the unit, Argentum Creations will replace the brick under this warranty.

* (For Grills or Inserts with the Rotisserie Option) The rotisserie attachment, including the motor, skewer, prongs and all other components carry a 1 Year Warranty against material defects and or workmanship from the date of delivery. We will, at our discretion, repair or replace the defective item within that warranty period at no charge to the customer.
